

HOOP HUNTER BASKETBALL INC (HHBI) POLICIES

Due to the rapid growth of the HHBI program, the following policies have been adopted and revised. These policies are necessary in order to assure an efficient and effective program. Please read the policies carefully and sign and date in the space provided. These policies are EFFECTIVE IMMEDIATELY and there will be NO EXCEPTIONS to any policy. If you have a question concerning the policies, please call the office at 817.491.9602. Our office hours are Monday – Friday, 9:00 a.m. – 1:00 p.m. Coaches are unable to take court time away from the athletes in order to discuss policies.

- There will be absolutely NO MAKE-UP LESSONS for any reason. This includes lessons that are missed due to illness, school, AAU, or BCI games and practices.
- There will be NO TIME SLOT CHANGES for any reason.
- Any lesson cancelled by Deon (or one of our trainers) will absolutely be rescheduled.
- All scheduling must be done through our office.
- Before a spot can be held, a deposit of ½ the fee must be received in our office. The remaining amount is due at the first lesson.
- A late fee of \$25 will be charged for payments not made on time. If after 2 weeks the payment has not been received, the time slot can be given to an athlete on our waiting list.
- If slot is cancelled or forfeited, a \$150 fee will be charged to your account. If this fee remains unpaid, you will not be allowed to participate in any Hoop Hunter programs until account is paid in full.
- Your time slot **is not** automatically held for future sessions. In order to secure a time, you must call the office and send a deposit (1/2 the amount).
- A time clock will be used to determine the start and finish of each workout. The clock begins at the scheduled workout time; not when you arrive. Try to arrive 10 minutes prior to your scheduled time in order to stretch properly. Please stay off the court until your lesson begins. There is to be no one else on the court when training is in progress.
- No trading workout times or sharing workout times with another athlete is allowed.
- Due to the growth of the program, it has become extremely difficult to schedule make-up lessons when Deon needs to cancel for personal reasons. If necessary, a substitute coach will provide the workout if Deon must be absent. Substitute coaches will be trained personally by Deon and will have a detailed workout plan written by Deon for each athlete. It is Deon’s goal to be present for each and every lesson; however, emergencies and illnesses must be planned for.
- Cell phones are a distraction. Please turn them off inside the gym and step outside to place or receive a call. It is important to remain quiet when training is in progress.
- There is to be NO videotaping during workout sessions. If you wish to videotape a session, approval must be obtained 24 hours in advance of a scheduled workout. Additionally, there will be a \$25 videotaping fee added to your account balance.
- There are to be no parent interruptions during workouts, such as negative comments made to the player. This is a hindrance to HHBI’s positive method of teaching and the parent may be asked to leave the gym.
- Parents are asked to keep conversations with all trainers before and after practice to a minimum. Please do not take away court time. Appointments with trainers may be made by calling the office.
- Should you need to speak with Deon Hunter or any of our trainers, please allow at least 24-48 hours for a call-back.
- HHBI reserves the right to discontinue lessons if it is felt that a player is not making progress due to a lack of commitment or effort.
- PARKING is allowed only in the first parking lot outside the campus. This is for the safety of the residents and their children.
